To form a Consortium for further development and exploitation of the Talentjourney platform.

NOTING that vocational education and training equip people with the knowledge, skills and competencies for specific occupations or more broadly on the job market.

NOTING that it is an important tool for protecting livelihoods and stabilising the economy. Today, more than ever, Europe must rally together to reinforce VET and build a more efficient, secure and prosperous future for all Europeans. This is an opportunity to take a fresh approach to VET, making it modern, attractive, flexible and fit for the digital age and green transition.

AWARE OF shared interests, objectives, responsibilities and leadership in developing, promoting, coordinating and offering the holistic experience for IoT life-long learners to go beyond its borders and to become a worldwide recognized IoT platform of excellence, and most of all to enable the best quality holistic experience for a learner.

The Undersigned AGREE to establish a reliable and sustainable partnership to support the further development of the Talentjourney platform with qualified, creative and skilled employees to secure the successful support and good quality realization of the main work package “learner experience”. The parties specifically agree to the following:

1. To jointly expand Talentjourney platform in the dimensions of:
  - User Experience.
  - Content.
  - Network.
  - Services.
2. To jointly develop and expand a new era VET system that will act agile, flexible, and innovative, green, digital, with no learner left behind. The new era VET system respects user-centricity and user-friendliness and will help each learner find his/her true potentials that will result not only in excellent professional but also in satisfied person.
3. To build and expand that kind of VET, the consortium needs to approach holistically regarding the contents, the provision of the contents, organisational models, partnerships and ecosystems, as well as digitally supported processes.
4. To strive for the sustainability of the Talentjourney platform, its’ maintenance and to raise funds and develop joint proposals for funding, to advance the shared objectives of the Talentjourney and member organizations.
5. To share governance, meetings, experts, activities and other best practices and lessons learned to promote better efficiency and effectiveness of the individual organizations.
6. This MOU may be amended from time to time, by written consent of all parties hereto, to (among other things) include other organizations joining the consortium.



7. Organizational representatives will communicate regularly (usually monthly meetings) to conduct consortium business, including the discussion and planning of the development of the Talentjourney platform.
8. All parties must diligently and conscientiously attempt to make decisions by consensus with full and careful consideration of minority views.
9. Each member organisation will nominate a representative to take care of the work and activities within the Consortium.
10. Additional organizations will be considered for the consortium membership by submitting a written letter of interest to the consortium members, participating in a consortium member meeting to describe their organization's interests related to Talentjourney, and then formalizing their intent in a letter to the consortium. A membership decision will be made by the consortium members during a regular meeting and then conveyed to the interested organization via letter.

This MOU shall become effective upon the signature of all parties hereto and may be renewed annually at the discretion of all parties hereto. Any party to this MOU may withdraw from the consortium upon two (2) weeks prior written notice.

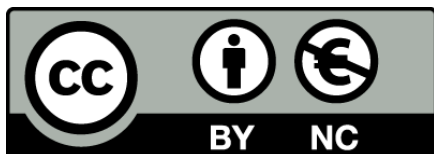
